May FY 2023 Financial Statements

Financial reports/statements have been submitted as of May 31, 2023. The numbers reflect ridership continuing to be up over past years. The operating expenses were down for the month by \$130,210. But we are running over budget year to date about \$376,957 primarily because of the hiring incentive programs that we've implemented over the last year.

Administrative Employee Compensation FY24

Ms. Douthat reviewed the FY24 administrative compensation memo included in the packet. Each year, the board approves the compensation merit matrix for administrative employees as well as the job grades/pay ranges.

Staff used a compensation consultant to conduct a full review of the administrative positions, rewriting job descriptions, reviewing position pay bands within market.

Several questions related to the compensation study, evaluation process for employees and compensation variances year over year were discussed.

Due to no committee meeting being held, the board requested that this item be moved for further review by the Finance committee in August. Staff will provide a full presentation at that time.

Mr. Parsons announced that this will be his last meeting serving on the TANK Board of Directors. Chairman Guenther acknowledged the Board of Directors' appreciation to Mr. Parsons for his service to the TANK Board and Finance committee.
